Selwyn Court and Library, Sunday 2 July

We will meet at the Selwyn Library at 3pm, at the entrance on St Stephens Ave, Parnell, opposite the west end of the cathedral. A talk will be given by an expert on Selwyn Court, which comprises the extensive Bishopscourt, a private church residence, linked to the library by a long corridor and very interesting architecturally.

After the talk, by kind permission of Bishop Ross Bay, we will be given the opportunity to visit the main rooms in Bishopscourt: the drawing room and dining room, which are of extreme architectural significance. We will round off the afternoon with refreshments back in the library, and would expect to finish about 5pm.

There is ample parking in the cathedral car park around the corner in Brighton Road and there are bus stops nearby also.

Donner House, Sunday 30 July

Donner House was built in the late 1940s by Tibor Karl Donner, chief architect to the Auckland City Council between 1946 and 1967. It is considered to be one of the finest examples of post war modernism in the country.

We will meet at the house at 50 Kohu Rd, Titi-rangi at 3pm. The owner, Paul Jenkin, who has restored the building, will give a presentation, after which we will be able to look around at leisure. We will finish off the afternoon with refreshments, in the garden, if weather permits. Parking is available on Kohu Rd.



Submissions

Recent submissions on behalf of CTA are as follows, with a quote from each.

Point England Development Enabling Bill

In our view, the loss of 11.69 hectares of recreational reserve land at Point England Recreation Reserve to enable housing development is undesirable. While we understand the need for housing, there are other measures that may help solve the housing shortage without the need to remove reserve land from the public realm.

Managing Microbeads in Personal Care Products

Civic Trust Auckland agrees with the Government's proposal [to prohibit the manufacture and sale of personal care products containing microbeads] because industry and individuals should not continue to pollute the oceans to the degree we have already. We depend on them as a food source, and the many animals living in the oceans need a clean and safe environment.

Auckland Council Annual Budget 2017/2018

We take encouragement from the written assurance accompanying this consultation process that, "Every piece of feedback is important and past consultations have shown that public feedback can and does change how the elected members make decisions."

Notified Resource Consent Application to authorise the demolition of the St James Church Hall

CTA suggests that the heritage values of the site will suffer a major adverse effect, with the demolition of the oldest, and arguably more significant building on the site.

National Policy Statement for Freshwater Management

CTA supports standards for our rivers and lakes that will make them safe for everybody to swim in at all times, and so this amenity will also be available to future generations.

Cherry Raymond's QSM Medal

Cherry Raymond was the chair of the steering committee that formed CTA and served for three years as vice president and president. She was a well-known freelance radio and television presenter and regular columnist for the NZ Women's Weekly. She contributed to many other community and arts groups, including Zonta. Several years back, Zonta asked if CTA would look after Cherry's medal, a role which Munroe undertook. Earlier this month, the medal was gifted to the Auckland Museum.

Illumination for Remembrance - St David's Memorial Church

The evening of April 24 saw this well attended event held outside St David's in Khyber Pass, the church that CTA submitted on in the Unitary Plan, the future of which seems much more certain as a result of the Friends of St David's fundraising success, under the leadership of Paul Baragwanath.

This event was one of a number that have been held to celebrate the church and raise money for its restoration, at the same time as commemorating soldiers who died in World War One.

The highlight was when the lights of the church were turned on, at the command of Nikki Kaye, MP for Auckland Central. She had spoken in support of the restoration project, as had other speakers, including Pippa Coom, the chair of the Waitematā Local Board; and Mike Lee, councillor for the Waitematā & Gulf Ward.

Musical items were performed by the Souls and the Gay and Lesbian Singers of Auckland. The Last Post was played on a World War One bugle, and bagpipes opened and concluded the formal part of the event. Audrey had played her flute as guests arrived.

Heritage architect Graeme Burgess then took a tour of the outside of the building, describing the details of the stained glass windows and the work involved in producing them.

CTA has supported the Art of Remembrance project in a variety of ways, and it was good to see a number of CTA members attend.
